FY 2017, 3rd Quarter Business Forecast Questions and Responses

Background

USAID's Business Forecast now provides "live" information throughout the fiscal year. The Agency's Business Forecast is an informational resource on potential funding and partnership opportunities at USAID. It is an advanced look at grants, contracts, and cooperative agreements that USAID is in the process of developing and plans to issue in the coming year. Organizations interested in working with USAID can use this tool to plan for proposal or application submissions.

General Business Forecast Questions

1. <u>Cancelled Opportunities</u>: For how long do opportunities whose status is changed to "Cancelled" remain in the Business Forecast database, so that they can be identified by filtering using the "Forecast Status Change" field?

USAID Response: We have advised AOs/COs that if they cancel an opportunity, it should remain on the Forecast for one quarter for the partners to reference. Please note that we continue to message this out to all of our staff.

2. <u>Forecast Download Sheet</u>: When downloading the Washington and Mission Forecast in XLS format, would it be possible to have this updated file format in alphabetical order by country/region?

USAID Response: The format of the downloadable excel version of the Forecast has been updated. You can now download the entire list of opportunities available, as well as your individual search options. All spreadsheets are broken down into Washington and Overseas opportunities, and then further alphabetized by Operating Unit or Country/Mission.

- 3. Small Business Set Aside Filter: Although the downloadable Excel version of the forecast includes a column titled "Small Business Set Aside", the live internet version of the forecast is not searchable by this field. Is this a feature that will be added to the live feed?
 USAID Response: Yes, we noted that this important feature was missing from the live feed when it was launched. We are happy to share that as of this weekend, you can now search by small business set asides. You can now filter by Small Business Set Aside, with options including:
 - o N/A
 - Total set-aside
 - o Partial set-aside
 - Small Disadvantaged Business set-aside
 - o 8(a) set-aside
 - Veteran-owned set-aside
 - Service-disabled Veteran set-aside
 - Woman-owned set-aside
 - o HUBZone set-aside
 - o Small Business Reserve, and
 - o TBD
- **4. Updating the Forecast:** The live feed is a new and useful format for the Forecast, however many opportunities have release dates that have lapsed or lingered without updates. When release

dates have lapsed, should organizations assume that the procurement has been delayed or interrupted? If that is the case, can USAID include such information in the Forecast? **USAID Response:** It is important to note that solicitation date is an "anticipated" date. When the date has passed it can be indicative of a number of items -- that the opportunity is currently open and has not closed, or that it may be delayed, or that an Activity that would be implemented through an A&A award is anticipated, but is still in design/planning. If you have questions about a specific opportunity on a date that has passed, we recommend reaching out to the A&A Point of Contact listed in the solicitation or the Business Forecast. We also have enhanced our website to include the email directory for the POC. You can also e-mail BusinessForecast@usaid.gov with questions.

- 5. Cooperative Agreement POCs: Is there a website or online resource that the general public can access to find out which organization has been awarded a specific cooperative agreement? USAID will often post Award Notices for contracts in FedBizOpps.com but Award Notices are not posted for cooperative agreements on Grants.gov. Is there a way to find out this information without having to email the POC each time?
 - **USAID Response:** The public can search <u>www.USASpending.gov</u> to view both acquisition and assistance awards. The Advanced Search feature allows you to search by Recipient Name, DUNS Number, or other keywords. See https://www.usaspending.gov/Pages/AdvancedSearch.aspx
- **6.** Task Orders on Forecast: Can USAID clarify whether Task Orders will be appearing on the live forecast? We had understood from previous quarter Questions and Answers that they would, but some missions have indicated that they are not required to post Task Orders on the live forecast.
 - **USAID Response:** Yes, Task Orders are included on the Business Forecast. They have been included for the last year and half.
 - If a Mission is telling you that task orders should not be included, can you please flag this to our BusinessForecast@usaid.gov email address?
- 7. <u>Information Missing from Forecast:</u> This past quarter we noticed that a number of opportunities disappeared from the Forecast en masse, only to appear a few days later. Can you share what happened?
 - **USAID Response:** In mid-April while making backend updates and testing new features of the Business Forecast, we noticed an issue where approximately 100 activities dropped off of the Live Feed. We addressed the issue as soon as it was noticed. This should not happen again.
- **8.** Extensions on Forecast: If a solicitation is in the final stages of the procurement cycle, competitive range determination, will any extensions or changes show up in the live feed or FedBizOpps?
 - **USAID Response:** For the Live Feed, once a solicitation closes there are no further updates to the Business Forecast.

Similarly on FBO.gov, once the solicitation closes, the CO generally does not post a public notice again until an award notice at the end of the process; however, there could be an instance where a CO may post an update to FedBizOpps. Any communications after proposal receipt through award (e.g., comp. range, discussions) are typically held with the offerors directly without any public notices.

Washington Business Forecast Questions

1. Africa: Nine African countries are likely to hold parliamentary elections in the upcoming 12-18 months, including Djibouti, Equatorial Guinea, Guinea, Guinea Bissau, Mauritania, Rwanda, Sao Tome, Swaziland and Togo. Does USAID expect to provide pre-electoral or electoral support in any of these countries?

USAID Response: USAID is analyzing options for future programming and may be seeking innovative ideas for the period leading up to the 2018 elections and beyond.

2. Africa: TASC4 Africa

a. Does USAID anticipate releasing opportunities using the TASC4 Africa mechanism in 2017?

USAID Response: USAID does not anticipate issuing a solicitation using TASC4 at this time

3. DCHA: Active Communities - Effective States (ACES)

a. Does USAID anticipate releasing a draft SOW or pre-solicitation announcement for ACES prior to issuing the full solicitation? If so, could USAID please indicate when it will release the pre-solicitation materials?

USAID Response: No. Our intent is to go straight to solicitation.

b. Could USAID confirm that the Anticipated Solicitation Release Date for ACES remains 9/01/2017?

USAID Response: Confirmed.

4. DCHA: Support Which Implements Fast Transitions (SWIFT) 5

- a. Can USAID please clarify if the rebid of the START small business mechanism will be included as the small business set aside portion of the upcoming SWIFT V IDIQ?
 USAID Response: At this time, we are at Market Research phase, and so all procurement methods and mechanisms are still being considered.
- b. The forecast indicates that this will be a partial small business set aside. The list of incumbents does not include any small businesses. For the new contract, how many small business awards will be made? Will the scope of work for the small businesses be different than for large holders?

USAID Response: At this time, we are at Market Research phase, and so these decisions have not been made yet.

- c. Can USAID please confirm the timing for the SWIFT V IQC is August 2017? USAID Response: Our intent is still to issue the solicitation by August 2017.
- d. Will USAID be hosting an industry day, draft scope of work, and/or issuing a draft solicitation?

USAID Response: An RFI is being prepared for the small business component of OTI's requirements. The main component of SWIFT will not have an industry day, draft SOW, or draft solicitation.

e. Does USAID anticipate issuing two sub-IQCs (each with a different geographic focus) for SWIFT V?

USAID Response: No.

f. Can USAID provide the anticipated number of awards for SWIFT V (for both full and open competition and the small business set-aside)?

USAID Response: 7 to 9.

5. DCHA: The PEACE IQC period of performance will conclude in 2017. Does USAID intend to release a follow-on. If so, what is the anticipated release date.

USAID Response: The PEACE IQC period of performance concludes in August 2018. USAID does not intend for a follow-on award at this time.

6. DCHA: Empowerment and Inclusion Support Mechanism (EISM)

a. Does USAID plan to manage EISM Empowerment and Inclusion Support Mechanism as an LWA grant type or as a standalone Cooperative Agreement?
 USAID Response: USAID plans to manage EISM activity as a standalone Cooperative Agreement.

b. Is the EISM program a follow on to an existing program, or is this a new opportunity? **USAID Response:** This is a new opportunity.

7. E3: Advancing Basic Education -- All Children Reading (ABE-ACR) IDIQ

a. Is USAID expecting any further task orders under this mechanism?
USAID Response: The period of performance for this IDIQ is five years from the date of award (July 2014). Although Task Orders may be issued at any time during this ordering period, the period of performance for a Task Order may not go beyond two (2) years after the end of the ordering period of the IDIQ.

8. E3: Learning, Evaluation, and Analysis Project III (LEAP III)

a. Does participating in LEAP III preclude the winner from priming or subbing on any other work either at 3E, missions, or programs in countries?
 USAID Response: USAID intends to include the appropriate organizational conflict of interest provisions and clauses in the LEAP III solicitation.

b. Could USAID please confirm if LEAP III will be free and open or a small business set aside?

USAID Response: USAID anticipates this procurement will be full and open for small businesses.

- Please confirm whether or not this will be a total small-business set aside.
 USAID Response: USAID anticipates this to be a total small-business set aside.
- d. Could USAID please confirm the solicitation release date?
 USAID Response: USAID anticipates the solicitation will be released in July 2017.

9. E3: PFM II IDIQ

- a. With the change of the solicitation date of LPFM III RFTOP to 2018, can USAID please confirm that LPFM will not be issued at the same time as PFM II IDIQ RFP?
 USAID Response: Correct, LPFM III will not be issued at the same time as the PFM II IDIQ RFP.
- b. Please indicate how many other-than-small awards USAID envisions as well as how many small-business set aside awards.
 USAID Response: USAID plans to set aside three awards for small businesses; however, USAID reserves the right to award more or fewer than three.
- C. Please indicate whether there will be any RFTOPs included in the IDIQ solicitation. USAID Response: No, there will not be a real RFTOP included in the PFM II IDIQ solicitation. However, an illustrative RFTOP will be included for evaluation purposes only.

10. E3: New LPFM III Task Order (Leadership in Public Financial Management)

- a. The LPFM III task order release date, was updated to 1/15/2018. The New PFM II IDIQ anticipated release date is 5/152017, with an anticipated award date of 12/22/2017. Initially New LPFM III was expected to be solicited as a Task order issued simultaneously with PFM II IDIQ. Would you explain the change?
 USAID Response: The LPFM III RFTOP will no longer be issued jointly with the PFM II IDIQ. LPFM III will be issued at a later date.
- b. Is New LPFM III Task order expected to be small business set aside? USAID Response: LPFM III will not be a small business set aside.
- C. USAID has previously included the LPFM activities under PFM, with an existing IDIQ holder implementing both LPFM and other task orders. However, an update to the forecast now separates LPFM out from the PFM II procurement. Does the separation of the LFPM activity from the proposed PFM II procurement have any implications for conflict of interest for the entities also competing for PFM II? Could suppliers under PFM II bid for and execute work under LPFM?
 USAID Response: LPFM III will be issued as a task order under the PFM II IDIQ.

11. E3: Data and Evidence for Education Programming

a. Can USAID please provide the contracting mechanism and set-aside type for the Data and Evidence for Education Programming solicitation?
 USAID Response: This is currently in the activity design stage - the contracting mechanism and set aside status has not yet been determined.

12. E3: Strengthening Tenure and Resource Rights II (STARR II)

a. Can USAID please confirm that it still intends to release the "STARR II IDIQ"?
 USAID Response: USAID does intend to release STARR II IDIQ. A presolicitation notice was issued on March 31, 2017.

13. E3: Data and Evidence for Education Programs (DEEP)

a. Can USAID please confirm the small business status of Data and Evidence for Education Programs (DEEP)?

USAID Response: This is currently in the activity design stage - set aside status has not yet been determined.

14. E3: Gender Learning Strategy

a. Under which mechanism does USAID plan to issue the Task Order? Will it be released under the USAID ADVANTAGE IQC?

USAID Response: The GEWE Gender Learning Strategy activity will be issued as a RFTOP under the ADVANTAGE IDIQ.

15. **E3:** Does USAID anticipate releasing a follow-on project to the E3 Analytics and Evaluation project? If so, can USAID provide more information on the anticipated timing and whether you anticipate a full and open solicitation?

USAID Response: Data and Evidence for Education Programs (DEEP) is currently in the activity design stage. No additional information is available at this time.

16. E3: REPLACE IDIQ

a. Can USAID confirm that the IDIQ will be re-competed and provide an anticipated solicitation date?

USAID Response: No information is available at this time.

17. E3: SEA SALT-Seafood Alliance for Legal Trade

a. The anticipated solicitation release date for the SEA SALT-Seafood Alliance for Legal Trade activity was 4/14/2017. Can USAID please provide an updated timeline?
USAID Response: A Request for Application No. RFA-OAA-17-000014 was issued on April 24, 2017, in response to a concept paper entitled "Sustaining Ecosystem Assets through a Seafood Alliance for Legality and Traceability (SEA SALT)." The concept paper was submitted in response to USAID FY 2016-18 Global Development Alliance (GDA) Annual Program Statement (APS) No: APS-OAA-16-000001.

18. Food Security: Advancing Women's Empowerment

a. Could USAID provide a scope of work for this sources sought?
 USAID Response: A draft scope of work will be released when the sources sought notice is issued on www.fbo.gov.

b. Could USAID clarify the contracting mechanism?
 USAID Response: The contracting mechanism has not yet been determined.

Does the Agency envision any set-asides?
 USAID Response: The agency will use the information requested from the sources sought notice to help inform its decision of a small business set-aside.

19. Food Security: Food Systems IDIQ

a. Could USAID confirm the anticipated release date of the IDIQ remains 6/30/17? USAID Response: The goal is to release the IDIQ RFP by 6/30/2017, however this date may change. USAID is currently reviewing all the responses to the RFI and incorporating select comments into the SOW.

- b. Does USAID intend on hosting an industry day for this opportunity, as it has for other similar mechanisms? Will another draft SOW be released?
 USAID Response: USAID is considering an industry day for the opportunity. If one is to happen, information regarding it will be released on www.fbo.gov. A revised Draft SOW will not be released. The final SOW will be released with the RFP.
- c. Will USAID provide information on this vehicle? USAID Response: A draft SOW was released on www.fbo.gov. That is the best source of information on this potential IDIQ at this time.
- d. Could USAID provide information on what the small business set-aside portion of the Food Systems IDIQ will look like?
 USAID Response: USAID is still determining how many of the IDIQ contracts will be set aside for small business and also a dollar threshold for Task Orders under the IDIQ contracts. We have determined that at least some of the contracts will be set aside for small business.
- e. Recognizing that the Notification of Sources Sought and Request for Information for this procurement states that the government will not be providing responses, has USAID considered distributing the questions and comments received?
 USAID Response: It was not USAID's intention to release the responses to the public, however it is something we can consider.
- f. As discussed in the FY17 2nd Quarter Business Forecast Q&A, has the RFI helped to clarify whether or not the project development activities would be restricted to a small-business set aside? If so, what was the determination?

 USAID Response: The responses to the RFI helped us clarify aspects of the SOW and our determination to set aside for small business. As discussed above, we have determined that a portion of this would be set aside for small business, however we have not determined how many of the IDIQ contracts, nor if there will be a Task Order dollar threshold implemented for small business holders (i.e. Task Orders under a certain dollar threshold would be competed amongst only the small business IDIQ holders).
- g. Has USAID clarified how many IDIQ contracts will be made under the Agri-food Systems IDIQ?
 USAID Response: USAID has not made a determination yet as to how many contracts

20. Food Security: Technology and Commercialization Partnerships

a. Can USAID please provide an update on this activity?
 USAID Response: This opportunity has been removed from the Business Forecast as USAID considers its options and the future of this activity.

21. Food Security: Seed Systems

will be awarded.

a. Please provide more detail on what is envisioned under the Seed Systems opportunity that is forecasted. Is this expected to be a global call, or are particular countries or regions prioritized?

USAID Response: This award will be focused on Feed the Future countries. We are still finalizing the Program Description. More information will be provided as that is further developed.

- b. Can the Bureau of Food Security provide an update on the anticipated release date of the Seed Systems solicitation previously anticipated to be released on 4/14/2017?
 USAID Response: We are working diligently on the final Program Description for this solicitation, and while a date for release has not been finalized, our estimate is that it will be solicited prior to mid-June.
- Can the Bureau of Food Security provide more detail on the nature of the solicitation in the Award Description column i.e. target countries/regions and parameters of the type of seed systems to be targeted?
 USAID Response: Done. Will focus on Inclusive and sustainable agriculture-led
- **22. Global Health:** FP/RH to Address Unmet Need: Regarding APS No. SOL-OAA-13-000024, USAID issued Synopsis 6 on February 7, 2017, reiterating that the due date for Round 3 concept notes was extended to August 31, 2017, and indicating that applicants should "disregard the supporting documentation (Revised APS dated December 17, 2017) that was included in Amendment No. 4."

- a. Could USAID please clarify whether a revised solicitation will be issued for Round 3, and if so, when this is anticipated to be released?
 USAID Response: At this time, there are no plans to issue a revised solicitation for Round 3. Please continue to monitor the business forecast for updates.
- b. Could USAID please also confirm that concept notes will still be accepted for Round 3? USAID Response: Yes, concept notes are still being accepted for Round 3, until August 31, 2017.
- 23. Global Health: Could USAID please indicate if it plans on releasing a successor program to the Health Finance and Governance program?
 USAID Response: Yes, USAID is planning a new program on Health Systems Strengthening.
- 24. Global Health: Medicines, Technologies, and Pharmaceutical Services (MTaPS)
 Are there any focus countries anticipated for this global health opportunity? How will the technology aspect be linked to achievement of other health objectives?
 USAID Response: This is a worldwide award. Focus countries will be determined during implementation. This award will include a focus on equitable access to essential medicines and other health technologies, and on their appropriate use.
- **25. Global Health:** *Global Health Technical Professionals*Will USAID please provide an update regarding the status of the G

Will USAID please provide an update regarding the status of the Global Health Technical Professionals (GHTP) Solicitation?

USAID Response: The GHTP procurement is still in the redesign stage. Unfortunately, there are no further updates. Please continue to monitor the business forecast for additional information.

26. Global Health: Accelerating Scale -- Human Centered Design

- a. Can USAID provide the instrument under which this will be procured, if the overall contracting mechanism has already been already awarded at the GSA or IDIQ level? USAID Response: The award has not been made yet and the new instrument is still in the design stage.
- Does USAID anticipate to release this opportunity as a small business set-aside?
 USAID Response: USAID does not anticipate this opportunity will be a small business set-aside.
- 27. Latin America and Caribbean (LAC): Does USAID intend to release a LAC monitoring and evaluation services contract under an IDIQ? The release date of 4/21/17 has now passed. Will USAID release a draft SOW? Which countries will this SOW cover?
 USAID Response: USAID does intend to release a LAC M&E services contract once the program office is finished with their review of the draft solicitation. This procurement is for Cuba though no travel to Cuba will be authorized.
- 28. Policy, Planning and Learning (PPL): Monitoring, Evaluation and Learning Staffing Support
 - a. The forecast states the anticipated solicitation date is on February 21, 2017. Could you please provide the updated solicitation date and anticipated award date?
 USAID Response: The solicitation was released on February 21, 2017 and closed on May 5, 2017. The anticipated award date is July 2017.
 - b. This is designated as 8(a). Would USAID consider opening up to other SB categories? **USAID Response:** The solicitation was for 8(a) concerns and has since closed.

Mission Business Forecast Questions

1. Afghanistan: Afghanistan Trade and Revenue Initiative (ATARI)

a. Afghanistan Trade and Revenue Initiative (ATARI) funding was decreased from \$25M-49.00M to \$10M - \$24.99M. Does USAID anticipate significant changes in the scope of work?

USAID Response: No, however maximum funding was reduced by \$6 million and the period of performance was reduced from 5 years to 4 years.

 b. Could USAID confirm that the Anticipated Solicitation Release Date for Afghanistan Trade and Revenue Initiative (ATARI) remains 5/30/2017?
 USAID Response: Yes.

2. Afghanistan: Afghanistan Business Environment Reform Project (ABER)?

Does the mission anticipate the re-announcement of the project?
 USAID Response: Not at this time.

3. Afghanistan: Afghanistan Monitoring, Evaluation, and Learning Activity (AMELA)

a. Would USAID be able to provide an updated solicitation release date for AMELA as the current Forecast date of April 24 has passed?

USAID Response: The new anticipated release date of the AMELA RFP is June 16, 2017; and the new cost estimate range has been revised to the lower end of the range of \$50M - \$90M"

4. Afghanistan: Value Chain -- Crops

a. Could USAID please clarify which regions the project will cover?
 USAID Response: It will be nation-wide in scope but only in locations where conditions make it feasible and permissible, and it is understood that interventions may need to be adapted to different regional contexts.

5. Afghanistan: Value Chain -- Livestock

a. Could USAID please clarify which regions the project will cover?
 USAID Response: Project is in design. Please check Fedbizops.gov for the solicitation in the future.

6. Afghanistan: Capacity Building & Extension Activity

a. Could USAID please clarify what type of award is anticipated?
 USAID Response: Award mechanism has not been decided. Award type will be updated on Business forecast as soon as known.

7. Afghanistan: Job Creation Project (AJCP)

a. Can USAID provide an updated anticipated release date for the Afghanistan APS opportunity?

USAID Response: The updated anticipated APS release date is June 01, 2017

b. Could USAID provide more information on the technical scope of this anticipated APS?

USAID Response: Under this Afghanistan Jobs Creation Program (AJCP) USAID/Afghanistan seeks to fund innovations that accelerate economic growth and diversification, resulting in a massive increase in sustainable employment (job creation) in Afghanistan.

- Is USAID considering a single or multiple awards during the length of the APS?
 USAID Response: USAID is considering to make multiple awards (up to 12 awards) under this APS.
- d. Has USAID considered specific locations provinces, districts of Afghanistan for the implementation? Any preference for urban or rural areas?
 USAID Response: There are no specific locations of Afghanistan identified for this activity and there is no preference for urban or rural. The program could be implemented in urban, peri-urban and rural areas of Afghanistan.
- 8. Afghanistan: Is USAID planning a new workforce development activity?

 USAID Response: If this related to the Afghan Jobs Creation Program, the information is currently listed on the business forecast.
- 9. Afghanistan: Capacity Building of Ministry of Public Works
 - a. Could USAID/Afghanistan kindly clarify whether the Capacity Building of Ministry of Public Works project is still anticipated in the future?
 USAID Response: After the current capacity building activity ends on August 2, 2017, USAID/Afghanistan does not anticipate continuing the program. At this time, the Mission will utilize its limited roads funding for operations and maintenance activities.

10. Afghanistan: Energy and Natural Resources Development Support (ENRDS)

a. According to the forecast the ENRDS opportunity has been "cancelled for the time being." The most recent results framework released by USAID/Afghanistan includes the Sub-IRs "natural resource management practices improved" and "access to electricity increased." Can USAID/Afghanistan kindly clarify how these Subs-IR will be addressed in future programming?

USAID Response:

The PTEC project components answer Sub-IR 1.1.1 Access to electricity increased, through:

- 1) The construction of transmission lines and sub-stations
- 2) Power access to Afghans who have never had grid power
- 3) Construction of a 10 MW solar plant in Kandahar
- 4) Installation of the third 18.5 MW turbine at Kajaki dam

Natural resource management practices improved is also addressed through the Mission's water/WASH portfolio, as well as Office of Agriculture irrigation and watershed management programming.

- b. Can USAID confirm a revised anticipated opportunity release date?
 USAID Response: USAID/Afghanistan is currently in process of defining its long term strategy regarding how the Sub-IR's will be addressed in the future.
- 11. Armenia: Market Liberalization and Electricity Trade

a. Can USAID provide an anticipated solicitation release date? This activity does not appear on the Business Forecast.

USAID Response: Currently USAID is reassessing the magnitude of the activity and anticipates to release the solicitation by the end of June 2017.

12. Bangladesh: Promoting Advocacy and Rights (PAR)

a. Could USAID provide more information on the level of information to be required at the Expression of Interest (EOI) stage for the Bangladesh Promoting Advocacy and Rights (PAR) Activity?

USAID Response: Our determination on all required information has not been made at this time.

b. What is the time period between the EOI phase and the final/second stage of the solicitation

USAID Response: That information has not been determined yet.

c. Given the modified release date, please clarify when USAID expects to invite Expressions of Interest.

USAID Response: An anticipated release date cannot be determined at this time. Please continue to monitor the Grants.gov website.

d. Does USAID anticipate that this two-stage selection process will be through a Broad Agency Announcement (BAA) mechanism?

USAID Response: A BAA is not anticipated.

e. Can USAID provide more information on the scope of this activity? **USAID Response:** The activity is still in the design stage.

f. Can USAID provide the award ceiling for this opportunity? USAID Response: The award amount is anticipated to be in the range of \$4 to 9.99 million.

g. Can USAID confirm the anticipated release date for this opportunity?
USAID Response: An anticipated release date cannot be determined at this time. Please continue to monitor the Grants.gov website.

13. Bangladesh: Feed the Future Nutrition Activity

a. The Anticipated Solicitation Date of 2/12 has passed. Can you please provide an update on the timing?

c. Can USAID kindly confirm if the design of the activity is complete? **USAID Response:** The activity is still in the design phase.

d. Can USAID share more information on the proposed program description? **USAID Response:** Not at this time.

e. Can USAID kindly confirm that this will be an RFA? **USAID Response:** USAID anticipates that the solicitation will be an RFA.

f. Can USAID kindly confirm that it will NOT be releasing an RFI for this opportunity? **USAID Response:** USAID will not be soliciting an RFI at this time.

g. Can you please confirm the likely duration (in months) of the Rural Resilience opportunity included on the Nigeria Mission Forecast?

USAID Response: Up to five years.

- h. USAID Response: Bilateral activities anticipated: Securing Water Supply, Environmental Justice, Promoting Green Growth in Peru, Securing a Sustainable, Legal, Profitable and Inclusive Forest Sector, and Alternative Development activities.

Regional activities anticipated: Promotion of Best Environmental and Social Management Practices, Representation of Indigenous Peoples in Governance of Amazon Forests and Waters, SERVIR, and Amazon Knowledge and Learning Platform.

b. For the regional projects can USAID provide further description of the participating countries?

USAID Response: As a minimum, Brazil, Colombia, Peru are anticipated countries.

c. We understand that the only regional opportunities will be: Promotion of Best Environmental and Social Management Practices, Representation of Indigenous Peoples in Governance of Amazon Forests and Waters, and Amazon Knowledge and Learning Platform. Can you confirm?

USAID Response: SERVIR will also be regional.

USAID Response: USAID/Peru received an extension of its current CDCS until June 2019

 USAID Response: Yes, it will.
- 106. Peru: Promotion of Best Environmental and Social Management Practices

USAID Response: Yes, USAID Policy is to conduct market research for all opportunities.

- b. Has funding been set aside for this activity?
 USAID Response: As listed in the Business Forecast.
- c. Is the activity intended to be specific to BMP as they relate to the country of Peru only, or will it have an Amazon regional focus?
 USAID Response: It will be a Regional activity.
- **107. Philippines:** Could USAID/Philippines please indicate if they are planning any new activities for FY17/18?

USAID Response: Yes, these are listed in the Business Forecast and more to follow at the appropriate time.

- 108. Philippines: Environment Sector Activity(ies)
 - a. Can USAID please confirm the release date of the "Environment Sector Activity(ies)" to be 9/29/2017?

USAID Response: The planned solicitation date for the Environment Sector Activity(ies) remains at 9/29/2017. Updates will be made when appropriate.

 - a. This opportunity has been removed from the forecast. Does USAID still expect to issue a solicitation for this opportunity, and if so, when might this be expected?
 USAID Response: Yes. This is in the early stages of design; however, please expect an update in the Business Forecast shortly.
