FISCAL YEAR 2012 (FY 12) CONFERENCE REPORT

In May 2012, the Office of Management and Budget (OMB) issued Memorandum M-12-12, <u>Promoting Efficient Spending to Support Agency Operations</u>. The memorandum outlined a series of new policies and practices regarding conferences and directed agencies to report conference expenses for the previous fiscal year on their public websites beginning January 31, 2013. This report provides a summary of expenses incurred by the U.S. Agency for International Development (USAID) for conferences held from April – September 2012.

In April 2012, USAID launched a centralized, web-based conference approval and tracking system, the eConference Tracking and Approval System (eCTAS). The system captures requests for conference approvals from Washington offices and missions worldwide, and facilitates senior management review and approval of conference expenditures. This report covers events held since its implementation.

During FY 12, USAID issued comprehensive policies and other controls to mitigate the risk of inappropriate spending on conferences. A chapter on conference planning and attendance was incorporated into Agency operational policy through the <u>Automated Directives System</u> (ADS), which is available to the public and USAID staff worldwide. The conference policy guidance documents the review process for conference expenses, including the following approval requirements:

- The Chief Operating Officer must approve estimated expenditures up to \$100 thousand;
- The Deputy Administrator must approve estimated expenditures between \$100 thousand and \$500 thousand; and
- The Administrator must approve expenditures and provide a waiver for estimated expenditures over \$500 thousand.

The Agency's review of conference expenditures ensures compliance with Agency and federal policies. Conferences must support the achievement of the Agency's core development or management objectives and/or provide critical training relevant to the work of Agency employees.

Since the launch of the eCTAS in April through the end of the fiscal year in September, USAID is reporting conference expenses of \$2.79 million. Eighteen of these conferences were directly sponsored by USAID with total estimated expenses of \$2.47 million. A total of 1,067 USAID employees participated in these events, along with 1,465 outside participants. Additionally,

USAID employees attended 63 conferences not directly supported by USAID during the reporting period at a total estimated cost of \$315 thousand for travel, per diem and registration fees.

From April through September, USAID sponsored four conferences with net expenses in excess of \$100 thousand. Per Memorandum M-12-12, additional information is provided on these conferences in the annex. M-12-12 also requires that agencies publish a waiver signed by the agency head to incur expenses exceeding \$500,000 on a single conference. During this reporting period, USAID sponsored one conference that exceeded this threshold. USAID did not seek a waiver for the expenses because approval to sponsor the event and commit funds was granted prior to the issuance of M-12-12 and the launch of the Agency eCTAS.
